Minutes of EGM meeting held in the centre on Tuesday 2nd September 2025

1. Welcome: P Prior welcomed everyone to the meeting

2. Minutes of Last Meeting:

Minutes of the June meeting had been distributed and were proposed by P Prior and seconded by L Hutchinson with one change: date of Blood Transfusion visit in November is Monday 10th not Wednesday 10th.

3. Correspondence: None

4. Changes to BCCA Constitution

M Norton raised a point that the proposed changes should have been raised at a committee meeting as per the consitution and not discussed via Whatsapp. However, the changes had been shared and the 21 days' notice of EGM given as per the constitution. The Committee agreed to go ahead and discuss the changes.

The need to review the constitution arose due to a query as to whether the BCCA should be registered as a charity and questions around the BCCA tax status. P Prior gave a brief overview of these issues and how they were addressed.

Charitable status - the BCCA insurance provider had suggested we needed to be a registered charity because our income exceeded £5500 but this is only a requirement in England and Wales not Scotland. Becoming a charity in Scotland would involve BCCA in a significant amount of extra professional fees (legal, accts, co reg) and volunteers time for no real benefit based on how we currently operate. So BCCA will remain as now an unincorporated association like many clubs and voluntary bodies.

Tax status - it was also suggested that BCCA may be liable to corporation tax on our lettings income after expenses. However, we have been advised that there is no need to register with HMRC for corporation tax as we operate for "community benefit" and are not "trading with the intention of making a profit". We will therefore continue to operate as we are and improve the community centre and its facilities where this is possible and practicable.

Changes to the Constitution – P Prior outlined the changes that had been made to the constitution:

Item 2 (i) removal of the word "each" from "each regular user"

Item 2 (v) "Maximum term in office is 3 years" removed

Item 2 (vi) changed to "Bishopton residents shall be elected at the AGM"

Item 2 (vii) removed

Item 3 (v) "Employ staff..." changed to "Engage contractors..."

Item 3 (vii) changed to "Receive income from letting charges set by the committee"

Item 4 (ii) "in local library" changed to "on BCCA website"

Item 4 (iii) "a minimum of one third of the membership of the committee" changed to "a minimum of 6 members of the committee"

Item 9 (i) removal of sentence: "No alterations shall be made which would have the effect of causing the association to cease to be recognised by the Office of the Scottish Charity Regulator as a charity"

Those present discussed the changes proposed and also raised points on some other items in the Constitution. Following the discussion a formal vote was taken. There was a unanimous decision to adopt the proposed changes. No other changes were made.
